Appearances

Camellia Maids appearances will also include many video appearances, as well as hosting and/ or coordinating awareness campaigns and donation drives. When participating in appearances, volunteer hours may be earned for other organizations while being a valued ambassador for the City of Semmes.

Required Appearances

Dates will be given as soon as they are set.

- Farmer's Market (Girls must attend one during the month of June).

Rules of Conduct

As a Semmes Camellia Maid, you will represent yourself, your community, and this organization. For this reason, the following rules of conduct always apply to any candidate and Semmes Camellia Maid.

1. The Camellia Maid interview process is open to females living in the Semmes area who are 13 to 19 years of age at the time of application. If selected, the girl will serve a two-year term as a Camellia Maid. During the time of service as a Camellia Maid or applicant, she must adhere to all Rules of Conduct.
2. Semmes Camellia Maids are prohibited from engaging in any act of delinquency, criminal conduct or committing any crime as defined by the laws of the City of Semmes, State of Alabama, and/or the United State of America. An arrest, indictment, conviction, imprisonment, placement in a youth center or other similar establishment, and/or placement on probation, or expulsion from school shall constitute a violation of this rule and result in immediate dismissal.
3. Semmes Camellia Maids are prohibited from taking, using, posting, distributing, possessing, or otherwise, pornographic and/or nudes of themselves, or other individuals, of the following: (a.) Photographs (b.) Videos (c.) Drawings (d.) Other depictions.
4. Semmes Camellia Maids will remain unmarried and without child throughout her term.
5. Semmes Camellia Maids are prohibited from purchasing, selling, using, distributing, consuming, possessing or otherwise, of the following: a. Drugs of any kind (including but not limited to (a) marijuana (in any form), delta 8, amphetamines, etc. (b). Prescription drugs/medications (not prescribed to the girl) (c.) Alcoholic beverages and spirits (d.) Cigarettes, cigars, or vaping materials.
6. Semmes Camellia Maids are prohibited from using profanity or other derogatory and/or offensive language or actions, and engaging in defamation, slander, or libel of any other individual or other entity.

7. A Semmes Camellia Maid shall not allow a third-party to take, display, post or distribute any photographs or videos depicting a Camellia Maid engaging in any of the conduct described in rules above or that are otherwise deemed inappropriate by City of Semmes officials.
 8. The Semmes Camellia Maid program has a zero-tolerance policy against bullying. If proven guilty of such acts, the Camellia Maid will face disciplinary action as outlined in number 23 of the Rules of Conduct.
 9. Semmes Camellia Maids must always comply with the requirements of her school and/or the Mobile County Public School System regarding conduct. Engaging in any conduct resulting in suspension from or other disciplinary action imposed by her school; or engaging in any other conduct considered inappropriate by the City of Semmes may result in disciplinary action as outlined in number 23 of the Rules of Conduct.
 10. All communications from the City of Semmes are confidential and are intended only for the use of the recipient.
 11. A Semmes Camellia Maid is prohibited from releasing a statement, an opinion, and/or participating in an interview with any press outlet, social media, or otherwise on the behalf of the Semmes Camellia Maids or City of Semmes unless permission has been given by the City of Semmes.
 12. A Semmes Camellia Maid may not sell, use, distribute, or otherwise allow any third party to sell, use, or otherwise distribute the name and/ or logo of "Semmes Camellia Maids", or "Camellia Maid" without written approval from the City of Semmes.
 13. A Semmes Camellia Maid shall not wear, use, or display her dress except for official appearances coordinated and/or approved by the City of Semmes, family events, and/or personal photography or video sessions. The lending of dresses to parties outside of the program is prohibited.
 14. Semmes Camellia Maids will check and respond to all communication outlets (i.e.: texts, Facebook posts, emails, etc.) at least weekly.
 15. Semmes Camellia Maids are responsible for attending all mandatory scheduled appearances and encouraged to attend optional appearances. Failure to attend

mandatory appearances without prior approval will result in disciplinary action as outlined in number 23 of the Rules of Conduct.

16. Semmes Camellia Maids must follow the direction from the City of Semmes Representative, Team Leader and/ or Camellia Maid Ambassador while at official Camellia Maid appearances and/ or city events.
17. Individuals, except for a parent/guardian, team leader or Camellia Maid Ambassador, are prohibited on official appearances, trips, or otherwise.
18. While on an official appearance, the following are unacceptable: (a.) Chewing gum (b.) Wearing jewelry, other than pearls approved by the City of Semmes (c.) Visible tattoos (d.) Elaborate hairstyles (e.) Nail polish except very light, natural colors (f.) poor hygiene.
19. While on official appearances or in a meeting, Camellia Maids shall not use electronic devices unless the Camellia Maid is on a scheduled break out of the public's eye or unless an electronic device is required for the service performed.
20. All Semmes Camellia Maids will arrive to appearances 15 minutes prior to the start time of the appearance ready with the appropriate attire as scheduled.
21. All Semmes Camellia Maid appearances must be scheduled and approved through the City of Semmes. Requests for appearances should be directed to City of Semmes Representative or emailed to camelliamaids@cityofsemmesal.gov
22. Semmes Camellia Maids should read and study the monthly newsletter distributed by the City of Semmes to stay up to date with the most current projects and events. Camellia Maids should be comfortable discussing this information with persons interested in the progression of Semmes and upcoming community related aspects.
23. Any violation of the Rules of Conduct may result in disciplinary action at the discretion of the City of Semmes. Disciplinary action includes, but is not limited to, community service, temporary suspension, and/or permanent dismissal from the Semmes Camellia Maid Program. Disciplinary action is viewed on a case-by-case basis with the City of Semmes holding full discretion of the disciplinary action taken depending on the severity of the violation.

24. Under most circumstances, communication regarding disciplinary actions will proceed as follows: 1. Verbal warning 2. Written warning, with parental communication 3. Final written warning may include, but is not limited to, community service, suspension, or dismissal of the Semmes Camellia Maid Program

25. If at any point during the time of service as a Camellia Maid the individual violates the Rules of Conduct leading to dismissal from the program, the individual will be responsible for refunding the cost of the dress back to the City of Semmes.
